#### Brief information on Joint Stock Company «DORI-DARMON» in Tashkent region

#### Company name:

The Company's Charter has been approved by the decision of the General Meeting of Shareholders dated April 25, 2003, registered by decision of the Khokim of Yakkasaray district of Tashkent under №1459, dated October 7, 2003. The authorized fund of the company was UZS 88,150 thousand consisting of 88,150 shares with a par value of each share of UZS 1,000. In pursuance of Decree of the President of the Republic of Uzbekistan №4053 dated 18.11.2008, "On further measures to further improve the financial stability of the real sector of the economy", by increasing the nominal value of shares of Open Joint Stock Company "Dori-Darmon" in Tashkent region by capitalizing retained earnings of 2008, the Authorized Fund of the company, according to decision of the general meeting of shareholders dated February 23, 2009 was increased by the amount of UZS 572,975 thousand and the par value of every share in the company amounted to UZS 6,500. Based on the decision of the general meeting of shareholders dated May 20, 2013, the Authorized fund of the Company was increased by the amount of UZS 634,680 thousand and the par value of shares in the company amounted to UZS 7,200.

However, due to the fragmentation of the company's shares and the exchange of previously issued shares for newly issued shares with a reduced par value under the decision of the meeting, 881,550 shares were placed with a total par value amounting to UZS 634,680,000, with a par value of each share of UZS 720. As a result, the amount of the authorized capital totaled UZS 634,680,000.

In order to bring the name of the company in compliance with the requirements of the Law "On joint-stock companies and protection of shareholders 'rights" to approve the following name by the resolution of the Extraordinary Shareholders' Meeting dated September 20, 2014, the name of Open Joint Stock Company Toshkent viloyati «DORI-DARMON» was changed to Joint Stock Company Toshkent viloyati « DORI-DARMON ».

By decision of the Supervisory Board of the company dated October 30, 2014, at the expense of part of net profits amounting to UZS 70,520,000, received following the results of 2013, the increase in the authorized fund of the Company by increasing the nominal value of shares from UZS 720 to 800 was approved with bringing the authorized fund (capital) to UZS 705,200,000, the decision and the issue prospectus for a new issue of 881,500 shares with a par value of UZS 800, instead of each share with a par value of UZS 720 in the amount of 881,500 shares were approved and presented for registration at the Tashkent regional Department of the Center for coordination and development of the securities market.

Main activity: to provide the population of the Republic of Uzbekistan and medical and preventive treatment facilities of Tashkent region with pharmaceuticals and medical devices.

By decision of Khokim of Yakkasaray district of Tashkent №1459 dated October 7, 2003, State Joint-Stock Company "Dori-Darmon" in Tashkent region was reregistered and renamed to Open Joint Stock Company "Dori-Darmon" in Tashkent region.

The authorized fund of Joint Stock Company «Dori-Darmon» has been formed by 88,150 pieces of shares with a par value of each share of UZS 7,200 totaling UZS 634,680 thousand.

As of December 1, 2014 the amount of the Authorized fund of Joint Stock Company "Dori-Darmon" in Tashkent region is UZS 705,200,0 thousand (seven hundred five million two hundred thousand). #### Marketing Plan of the Company

As of 2014 the structure of OJSC "Dori-Darmon" in Tashkent region included 17 operating regional and central urban pharmacies and their branches, 1 inter-hospital pharmacy, pharmacy departments subordinating to the company and a mobile pharmacy attached to a car. The objective of the mobile pharmacy is to provide medicines to the population living in rural areas of Tashkent region.

In order to better meet the needs of the population and medical and preventive treatment facilities, the delivery of 1850 types of finished pharmaceuticals and medical devices is performed. Also, our purpose is the further development of trading activities of pharmacies and their branches subordinating to the company. One of effective way of solving the problem is to extend the range and increase the number of medicines manufactured in pharmacies.

In 2014 the Company carried out the import of foreign medicines and medical products in the amount of 2,505,000 US dollars and received a discount in the amount of 765,930 US Dollars. In 2015 it is planned to import foreign medicines and medical devices in the amount of 2,850,000 US dollars and get discounts in the amount of 785,000 US Dollars.

From the companies operating in the country and producing medicines for 9 months of 2015 medicines of 670 types in the amount of UZS 1,747,657 thousand and discounts were received in the amount of UZS 261,419 thousand.
